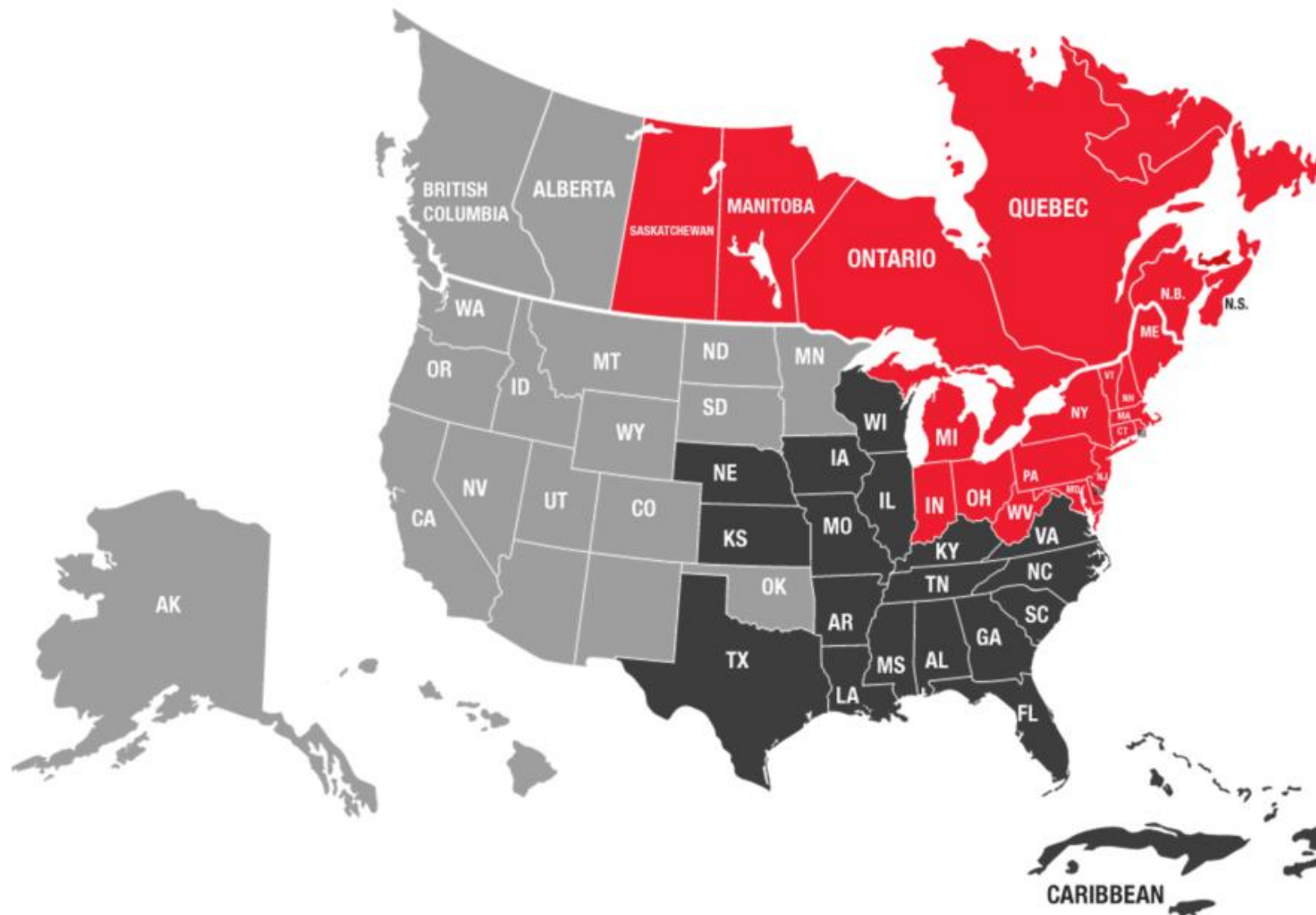


Division Map

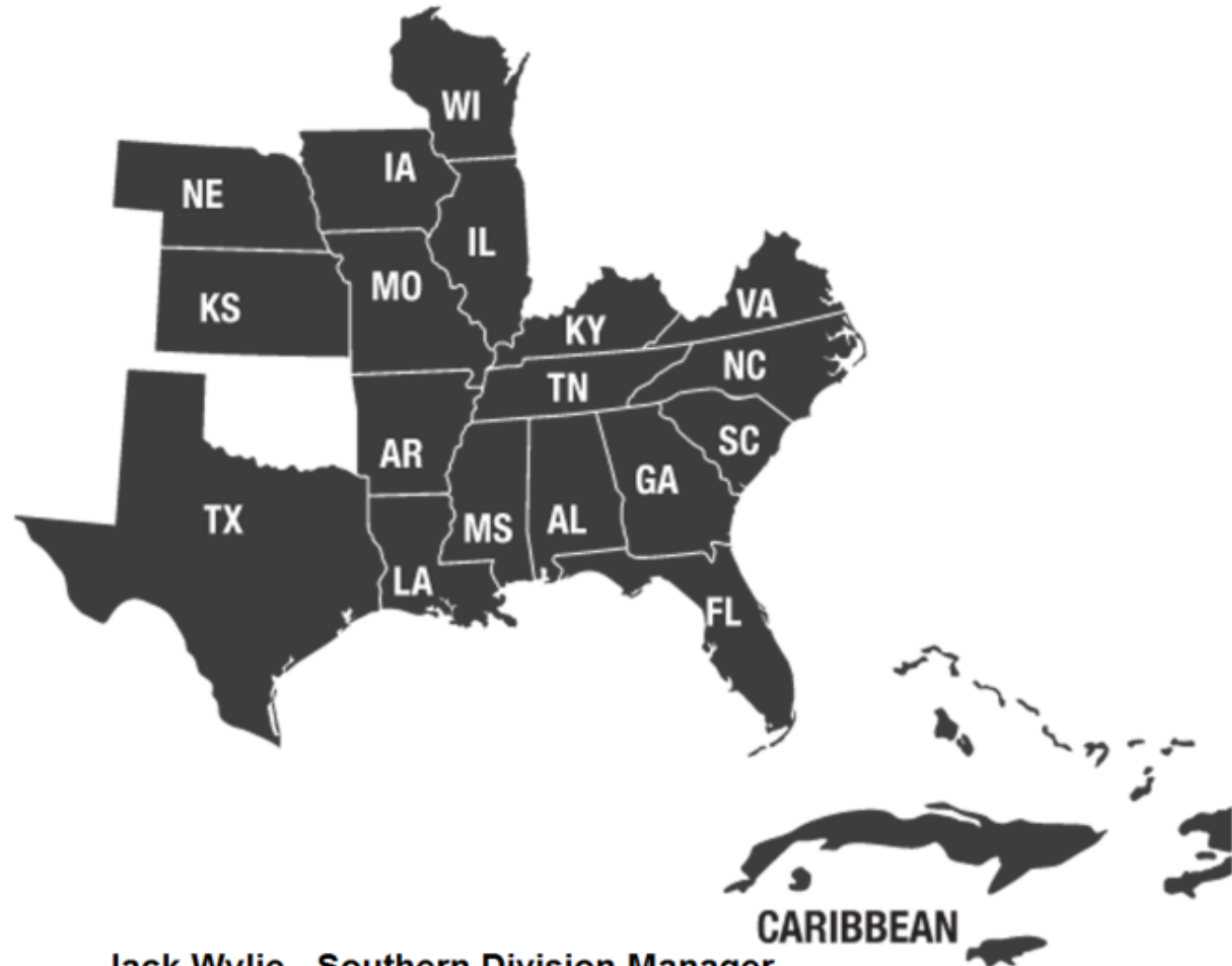

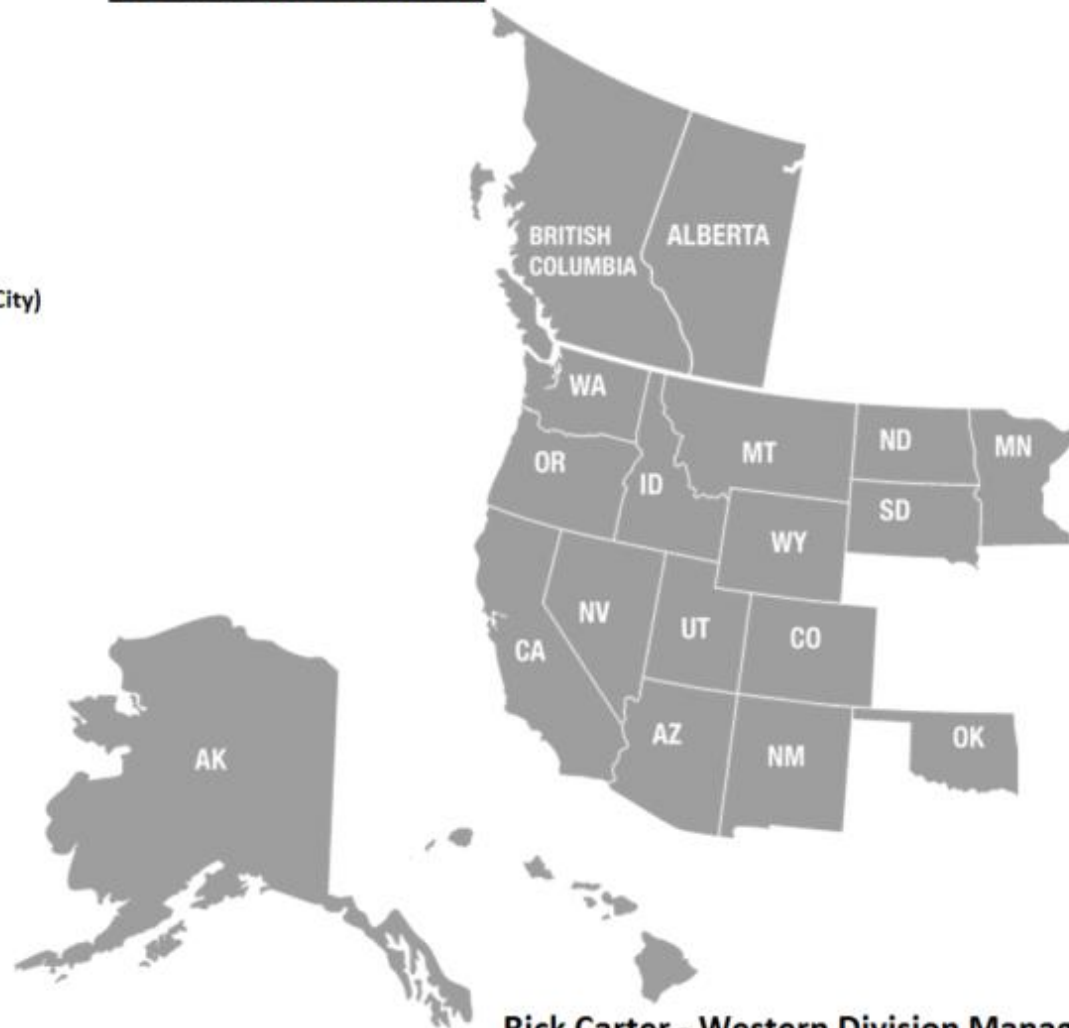
