

Written authorization from SAF-HOLLAND must be obtained prior to returning any part or parts. No charges for transportation or for labor performed on SAF-HOLLAND products by unauthorized persons will be allowed under this warranty. SAF-HOLLAND extends a limited warranty on all Consumer Products (products normally used for personal, family or household purposes) to the retail purchaser only. A copy of the current Consumer Products Limited Warranty for extension to the retail purchaser may be obtained from SAF-HOLLAND upon request.
